#### **Survey Overview**


- Collected responses over a two week period
- 90% of responses from Australia
- Limited number of responses removed due to incomplete data
- Majority of responses from tax & accounting and payroll & employee services space








#### Impacts on Business Software Providers



- Over 90% of respondents were impacted by COVID-19
- ABS 74% of businesses changed how they operate, 72% of businesses saw decrease in revenue




#### Changes in Revenue




- 52% expecting decreases in revenue
- Potential impacts of stimulus measures keeping some respondents/the industry afloat






### **Changes in Customers**

- No real change, mixed between increase and decrease in customers
- Perhaps customers just reacting to COVID-19 or taking the opportunity to reduce costs or switch providers




#### What is the Industry Worried About?




- Majority worried about their customers
  - Their survival and financial viability
  - Potential cash flow effects from customers cancelling/downsizing
- Worried about running businesses remotely, productivity of staff, remotely managing projects




#### Transitioning Back to Work in the Office








#### Changes to Workplaces

  - Work (reduced air travel, online meetings)
  - Discounts, sales and marketing methods




# Will the Next 12 Months be a Significant Time for Innovation and Technological Change?



- Majority yes
- Answering no or maybe:
  - Depends on government's policy direction
  - Lack of investment funds, financial uncertainty, loss of income may inhibit innovation



#### **Attitudes Towards Cyber Security**



- Majority yes
- Answering yes:
  - Working from home raised cyber security issues. Priority moving forward
  - Working from home not as secure as workplace
  - Fraud and media exposure drive improved security requirements
